A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared. The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component.

The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR).

Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e.  $Sf = 1000 \times Fm / F$ , in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

Submission obtaining the highest weighted points (technical points + financial points) will be selected.

An interview with the candidate given the highest combined score may be held before contract awarding, if deemed necessary.

# TERMS OF REFERENCE (TOR) – English version

# INPUTS INTO THE REVISION OF THE LAW ON ENVIRONMENTAL PROTECTION IN VIET NAM (LEP)

Assignment: National Consultant for analysis, assessment and proposal of possibility of integration of climate change and green growth issues into the LEP (revised)

### 1) GENERAL BACKGROUND

The 2005 Law on Environmental Protection (LEP) was passed on the 29<sup>th</sup> November 2005 by the National Assembly, Legislature XI of the Socialist Republic of Viet Nam at its 8<sup>th</sup> Session, the Law takes effect from the first of July 2006. It includes 15 chapters and 136 articles. After 5 years of its implementation, the LEP has contributed significantly to the environmental protection meeting the demands of socio-economic development of Vietnam.

However, the LEP has presented a number of provisions, which are no longer consistent and appropriate with practice causing difficulties and confusion in the implementation. There are overlaps and discrepancies between LEP and other related legal documents as well as overlaps of environmental management responsibilities among governmental agencies. In addition, there have been number of new emerging issues such as a well balance among social, economic and environmental benefits, climate change, green growth, and so on which was not taken into account while developing the LEP.

The revision of the LEP has been included in the Law Making program of the NA (tenure XIII). A revised LEP is expected to be submitted to the NA in September 2013.

Of the new emerging issues, climate change (CC) is a critical one that requires detailed analysis to evaluate the possibility of integration of climate change and green growth issues into the revised LEP. Climate change adaptation and integration of adaptive measures into the environmental protection management need to be considered and analyzed to identify issues to be regulated by the revised LEP.

### 2) OBJECTIVES OF THE ASSIGNMENT

The objectives of this assignment are to:

- 2.1 Review and analyse existing policies, international experience and the possibility of integrating climate change and green growth issues in the revised LEP;
- 2.2 Make detailed proposal on integration of climate change and green growth issues into the LEP (revised).

## 3) SCOPE OF WORK

## 3.1 Review, analysis and assessment of:

- The concept and policy framework, international experience, international agreements on climate change issues related to the environment that Viet Nam is a party to;
- Options for integrating climate change into the socio-economic development activities in general and environmental protection activities in particular;
- The environmental protection activities that adapt to climate change:
- The mandatory standards and monitoring and enforcement activities;
- Mechanisms to pilot, test, amend and adapt the integration of CC adaptation activities into environmental protection;
- Policies and trends of green growth;

- 3.2 Identification of newly arising issues in recent years or potential emerging issues on climate change and green growth in near future which need to be adjusted by provisions in the revised LEP;
- 3.3 Make recommendation on provisions to be added/ amended in the revised LEP in relation to climate change issues

#### 3.4 Presentation of findings at consultative workshops

#### **General requirements:**

- Consultative results are conformable with the national law and treaties which Viet Nam is a party (consideration within the relation of international treaties Viet Nam is already a contracting party or potentially to become party);
- Consultative results are satisfied with requirements of feasibility and applicability of the legal provisions.

The selected consultant is responsible for proposing a viable approach for the assignment. The following methodologies can be adopted.

- Desk review of the 2005 LEP and related laws and decrees, policies, regulations, standards and supporting circulars and directives governing environmental protection in Viet Nam. This will include any 2005 LEP reviews done by different agencies (if any);
- Intensive and regular consultation with the Department of Policy and Legal Affairs (DOPLA) and the Sustainable Development Cluster (UNDP);
- Interviews with relevant experts, government officials, and other stakeholders;

### 4) DURATION OF ASSIGNMENT, DUTY STATION AND EXPECTED PLACES OF TRAVEL

## 5) FINAL PRODUCTS

  - Assess the compatibility between the provisions on environmental protection to prevent and respond to climate change and those of international treaties to which Viet Nam is a party;
  - Analyze the provisions/regulations on environmental protection, green growth promotion and climate change adaptation in at least three countries (preferably Asian and ASEAN countries) to identify lessons learnt/ best practices for Viet Nam;
  - Predict new emerging issues or potential issues in relation to climate change adaptation that need to be addressed by the revised LEP;
  - Make recommendations on the addition/amendment of regulations on environmental protection, green growth promotion and climate change adaptation (suggestion of chapters/articles to be revised/added)
